

CONDITIONS OF ENROLMENT

This Studio values the opinion of parents and therefore should you need to discuss any aspect of your child's dance education or require further information on any of the following conditions please do not hesitate to speak with Miss Amanda.

Child Attendance: Children must be brought to and collected from the Studio by a responsible, authorised adult (16 years or over). Parents must inform the Staff personally if children are to be collected by an unauthorised person. Parents are required to advise the Studio if their circumstances change. All information contained on enrolment forms should be current.

Registration: A fee of \$11.00 per term will be charged to all students to cover Insurance, Licensing fees and Administration Costs.

Fees: Fees can be paid by Direct Deposit, EFTPOS, Visa/Mastercard, Cheque or Cash. Any cash payment not accounted for by the Academy will not be the responsibility of the Academy. Please make cheques payable to the Mrs Amanda Beasley t/as Amanda O'Rourke Dance Academy & The Danz Factory Studio of Performing Arts. Parents will be liable for any bank charges/fees due to dishonoured cheques. Amanda O'Rourke Dance Academy & The Danz Factory Studio of Performing Arts is a member of the Australian Creditors Association (Dun & Bradstreet). As such, we are obliged to manage our accounts in a professional manner and reserve the right to evoke a reasonable collection charge on overdue accounts.

No position in class will be held vacant for a child without fees being paid. If fees are not paid within the first five (5) weeks of Term the student/s will only be allowed to watch class, they will not be able to participate in class until all Fees are paid in full.

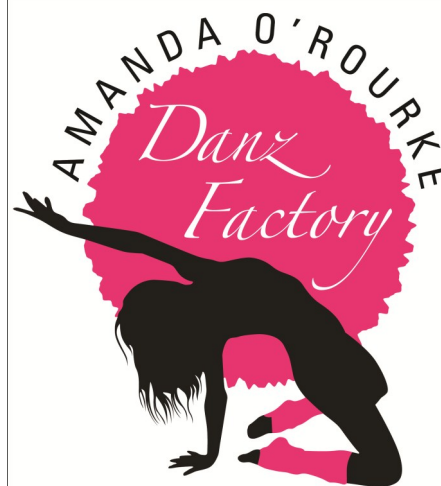
